

Disaster Preparedness

[Earthquakes] There are a lot of earthquakes in Japan.

They are unpredictable.

All residents in Japan need to always be prepared for them.

(Preparation)

- Secure the drawers and shelves in the rooms.
- Prepare enough food and water to survive for 3-7 days, as well as batteries, flashlights, and so on.
- Put necessary items into bags (emergency bags) for evacuation.

(In the event of an earthquake)

- Protect your head and wait for the tremors to stop.
- When the quake subsides, make sure to turn off gas and anything that may cause fire in your house and move (evacuate) to a safe place.

[Typhoons] They come frequently in summer and fall.

Recently in Japan, heavy rain and strong winds accompanying typhoons cause severe damage. Everyone should be prepared to be safe.

- When a typhoon comes, it is dangerous to be outside because of strong winds. Stay indoors at all times, except for evacuation.
- The water levels of rivers will rise. Always keep away from rivers.
- Gather information from the TV, radio, Internet, etc.
- Evacuate immediately when you feel you are in danger.

[Emergency drill(practice to deal with earthquakes and typhoons)]

Once a year, Suita City provides a drill for the citizens to evacuate safely, extinguish fire, and help injured people. Please join it as much as possible.

Interpretation assistance

For non-Japanese residents who are hesitant to go to hospitals or the city hall due to their Japanese communication skills, or for those who can speak Japanese but not confidently enough, volunteer interpreters will accompany them. No fees are required.

(For procedures and consultations at the city hall)

Library

There are 8 libraries and 2 branch libraries in Suita City. People can borrow books, magazines, comic books, DVDs, CDs, and ebooks as well as reading newspapers there at no cost.

[Eligible people]

- ①Suita citizens
- ②Those who belong to schools in Suita City
- 3 Those who work at companies in Suita City

[How to get a library card]

- Make a "library card" at the library.
- Bring the documents that show your address and name.

However, those who fall under category ② or ③ are required to bring the documents that show the location of their school or company.

[The amount of items to be borrowed]

- Books, magazines, and comic books: up to 15/person.
- DVDs and CDs: up to 3/person.
- Ebooks: up to 3/person.

[Reservation available]

You can search books and make a reservation on your computer or smartphone. For details, contact the nearest library.

Procedures for moving-in

Resident registration [Registering the address and family members of the new resident]

- New residents are required to notify Suita City Hall that they live in Japan, as well as registering their address and family size, etc. through resident registration.
- Non-Japanese people who are going to live in Japan (Suita City) more than 3 months (= those who have the residence card) are required to register as a resident at Municipal Division of Suita City Hall.

Certificate of residence [The document required to receive municipal services]

- After the resident registration, the city hall will make the certificate of residence, which contains the person's name, address, date of birth, status of residence (the certificate to live in Japan), etc.
- This is required to join Japanese National Health Insurance and National Pension, and to receive municipal services.

(Submitter of resident registration)

The new residents themselves are supposed to go to the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Senrioka).

In case you fall under category ① or ② below, your family member or a substitute can register as well. Be sure to call the city hall or a branch office to check the documents you have to bring before going there.

- ①The person has difficulty to go there (ex. illness).
- ②The person is younger than 15 years old.



Please be noted that special permanent residents must follow a different submission method.

[When the person moves to Suita City, they must submit the "moving-in notification".]

- This must be submitted within 14 days from the moving-in day.
- · Required Items

The moving-out certificate and the residence card/special permanent resident certificate

XIf you have your My Number Card, the moving-out certificate is not always necessary.

This system is called Exceptional Moving-in (Tokurei Tennyu).

*If you have your My Number Card (Individual Number Card) or Basic Resident Register Card, you should bring it to the city hall. The address on the card can be changed at the same time.

[When the person moves within Suita City, they must submit the "notification of change of address".]

- This must be submitted within 14 days from the moving day.
- · Required Items

Resident Card or Certificate of Special Permanent Resident.

 \divideontimes If you have your My Number Card (Individual Number Card), you should bring it to the city hall.

The address on the card can be changed at the same time.

[When the person moves from Suita City to another city, town or village, they need to submit the "moving-out notification".]

- This can be submitted approximately 14 days ahead of the scheduled moving-out day.
- Required Items

Residence card or special permanent resident certificate

**If you have your My Number Card (Individual Number Card), you should bring it to the city hall. The address on the card can be changed at the same time.



In case any changes occur in the submitted document (except for the address) or the residence card is lost, go to the Immigration Services Agency of Japan (Inspection Coordination Department of Osaka Regional Immigration Services Bureau) and make an arrangement.

Notifications, Certificates, and Taxes

How to apply for and receive "My Number" [My Number (Individual Number)]

- Whether they are Japanese or non-Japanese, "My Number (Individual Number)" is assigned to each person who is going to live in Japan more than 3 months.
- This number is used to identify the person's address and so on.
- If you register as a Japanese resident for the first time, the "notification for Individual Number" and the "application form for the Individual Number Card" will be sent to your address.
- Your name, date of birth, and Individual Number are written in the notification.

[How to issue your My Number (Individual Number) Card]

Suita City offers 3 methods. No fees are required.

①Applying by mail

Send the "application form for the Individual Number Card" to the Municipal Division of Suita City Hall by mail.

3 Applying at the city hall

Go to the Municipal Division of Suita City Hall.

(Required documents)

- Resident Card or Certificate of Special Permanent Resident.
- The documents that show your name and address/date of birth (ex. Health Insurance Card)
- A photograph of your face (3.5cm W x 4.5cm L)
- · Notification for Individual Number

[How to receive your My Number (Individual Number) Card]

(Mail/Internet applicants)

- You will receive the "notification of issuance" when your My Number Card becomes available.
- Go to the Municipal Division of Suita City Hall with the "notification of issuance", "residence card"/ "special permanent resident certificate", the documents with your name and address/date of birth (ex. Health Insurance Card), and the notification for the Individual Number.

(City hall applicants)

• Your My Number Card will be sent to your address with delivery restricted to the addressee.

Marriage Registration (Submitting the documents to notify the couple's marriage) [When getting married]

- You must obtain the "certificate of legal capacity/eligibility for marriage" (the document to prove the person is legally capable of marriage in Japan) at the embassy or the consulate.
- Submit the "marriage registration form", "certificate of legal capacity for marriage", and your passport to the Municipal Division of Suita City Hall.

Note

The necessary documents may vary depending on the non-Japanese resident's home country. Be sure to inquire with the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Senrioka) before going there.

Divorce Registration (Submitting the documents to notify the couple's divorce) [When getting divorced]

(Couples that consist of a non-Japanese and a Japanese resident)

- With the mutual consent of the married couple, the divorce will be effective under the Japanese law.
- Submit the "divorce registration form" to the Municipal Division of Suita City Hall or the branch offices (in Senri, Yamada, or Senrioka).

(Couples that consist of non-Japanese residents)

- Some conditions are required to get divorced under the Japanese law.
- Be sure to inquire with the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Senrioka) to check the required documents before going there.

- Those who get married or divorced are required to go through certain procedures in their home countries as well.
- Even if their marriage or divorce is permitted under the Japanese law, there are some cases that their country does not permit it. In case you get married/divorced, you should inquire with your embassy/consulate and the public office where you have to register it.
- When your status of residence or name changes because of marriage/divorce, you need to go to the Immigration Services Agency of Japan (Osaka Regional Immigration Services Bureau). If you are a special permanent resident, you should go to the city hall in your living area.
- The holder of the status of residence, whose spouse is Japanese or who lives in Japan as a family member of their spouse, may lose their status of residence when they get divorced.
- In case they do not arrange their status of residence, they may not be able to stay in Japan.

Birth Registration (Submitting the documents to notify childbirth) [When babies are born]

Submit the "birth registration form" to the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Senrioka) within 14 days from the birth.

(For non-Japanese parents)

- Even if your baby is born in Japan, they cannot acquire Japanese nationality.
- Notify the embassy/consulate that your baby was born.
- Go to the Immigration Services Agency of Japan (Inspection Coordination Department of Osaka Regional Immigration Services Bureau) to receive the residence card for the baby.

(Required documents to bring to the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Senrioka))

- Notification of Delivery (with the birth certificate issued at the hospital)
- · Maternal and Child Health Handbook

**Stamps (Inkan) are not required for non-Japanese residents.

(Acquisition of the status of residence for the baby)

The status of residence is essential for the children who were born in Japan without Japanese nationality to live in Japan.

- *If you are a special permanent resident, inquire with the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Senrioka) beforehand.
- The procedure must be completed at the Osaka Regional Immigration Services Bureau within 30 days from the birth.
- Those who are leaving Japan within 60 days from their birth are not required to go through the procedure.

Death Registration (Submitting the documents to notify the death of the person's family member) [When a family member dies]

- Please submit the "death registration form" to the public office within 7 days from the day you found out about the death.
- The place to submit the document is the public office in the residential area of the deceased or the submitter. Please request the doctor to fill out the "death certificate (post-mortem certificate)" that is on the right side of the death registration form and bring it to the office.

**Funeral homes can submit the form instead of you on request.

- The residence card, special permanent resident certificate, and alien registration card of the deceased must be returned to the Immigration Services Agency of Japan.
- Certain procedures are required in the home country of the deceased, which may vary depending on their countries. For details, inquire with the embassy/consulate.



Stamp Registration

- This is the procedure to register your personal stamp as the official one.
- The registered stamp is called "Jitsuin".
- After the registration, the city hall will provide you the "Stamp Registration Card (Inkantourokushou)".
- This is used when you make important contracts, such as buying a house or a car.

[How to register a stamp]

Go to the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Suita) to register your stamp.

(Required items)

- Residence card or special permanent resident certificate
- · A stamp to register



- In case you are not from a country where Chinese characters (kanji) are used, inquire with the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Suita) whether alphabet letters are acceptable.
- Even if your are from such countries, some Chinese characters are not available in Japan. For details, inquire with the Municipal Division of Suita City Hall or one of the branch offices (in Senri, Yamada, or Suita).

[Stamp Registration Certificate (Inkantouroku Shoumeisho)]

This is the document that proves your stamp is officially registered "Jitsuin". You can obtain the document at the Municipal Division of Suita City, one of the branch offices (in Senri, Yamada, or Suita), or the Public Service Corners (in Suita Thanks Bld. Esaka, Kishibe, Hara, or Kitasenri). If you have your My Number Card, it is also available at convenience stores. These services require fees. It costs 300 yen at the Municipal Division of Suita City, the branch offices, or the Public Service Corners, and 200 yen at convenience stores.

National Pension Plans

- All people who live in Japan, aged between 20 and 59 (including non-Japanese people), must join a National Pension plan.
- If a person aged between 20 and 59 joins the plan for 40 years, they will be able to receive the full old-age pension when they turn 65 years old.
- There are three categories of the members under the National Pension system.

1 Those who must join

(1) Category 1 policyholder

Self-employed people, students, etc. who live in Japan, aged between 20 and 59

(2) Category 2 policyholder

People insured by the Employees' Pension Insurance (except for those who are over 65 years old and covered by Old-age Employees' Pension)

(3) Category 3 policyholder

Dependent spouses of Category 2 policyholders (financially dependent on the insured people) who are aged between 20 and 59

2 Procedures to join

(1) Category 1 policyholder

The procedure must be completed at the National Pension Section of the Municipal Division of Suita City Hall.

(2) Category 2 policyholder

The procedure must be completed by the employer of the person's workplace, which means they do not need to do it by themselves.

(3) Category 3 policyholder

The procedure must be completed by the employer of the person's spouse's (including de facto marital relationship) workplace at the same time as submitting the "notification of health insurance dependent (transfer)".

3 Pension Contributions

(1) Amount

The amount of the contribution for Category1 is 16,590 yen per month from April 2022 to March 2023.

(2) Payment

Please pay the monthly contribution with the "national pension contribution payment guide" by the end of the following month.

You can pay it at financial institutions and convenience stores.

Payment by using bank account transfer or credit card is also available.

(3) Contribution Payment Exemption System

Those who have financial difficulty in Category 1 can apply for the Pension Contribution Exemption System or the Special Payment System for Students. These systems guarantee their rights to receive Old-age Basic Pension, Disability Basic Pension, etc. without paying contributions every month.

4 Payment of pension benefit

(1) Old-age Basic Pension

Those who have paid the Pension contributions for at least 10 years are eligible to receive Old-age Basic Pension after they turn 65 years old.

(2) Disability Basic Pension

Those who are covered by a national pension plan can receive this when disabilities are caused by illnesses or injuries (the date of the first medical examination is required).

5 Pension for non-Japanese people

(1) Lump-sum withdrawal payment for short-term residents

Non-Japanese people who have paid the contributions for a national pension plan or an employee's pension insurance for 6 months or more but who are ineligible to receive Old-age Basic Pension, can receive reimbursement of some amount (Lump-sum withdrawal payment) if they apply for it within 2 years after disqualification of their insurance and departure from Japan.

(2) Social security agreement

Non-Japanese people who live in Japan must join pension systems both in their home countries and Japan.

To ensure their qualification period of pension, the total insured period in both countries is counted, which makes it easier for them to fulfill the required insured period to receive the pension benefit.

Taxes

[Taxes] These are money paid for the national and municipal governments.

All people who work, live, and/or have assets (ex. land or houses) in Japan must pay taxes.

[Vehicle tax]

This tax, paid by those who earn money (ex. salary), goes to the national government. For details, contact Suita Tax Office.

[Resident tax]

Workers who live in Japan as of January 1st must pay this tax. For details, contact the Municipal Tax Division of Suita City Hall.

[Income tax]

Those who own the assets listed below as of January 1st must pay this tax. Land, buildings (ex. houses, apartments, stores), etc.

For details, contact the Property Tax Division of Suita City Hall.

[Fixed Asset Tax (environmental performance-based)]

This tax is usually included in the car price at the shop. For details, contact the Osaka Automobile Tax Call Center.

[Fixed Asset Tax(category-based)]

Those who own cars must pay this tax.

For details, contact the Osaka Automobile Tax Call Center.

[Light Vehicle Tax (environmental performance-based)]

This tax is usually included in the car price when buying a small-sized vehicle with three wheels or more. For details, contact the Osaka Automobile Tax Call Center.

[Light Vehicle Tax (category-based)]

Those who own motorcycles or vehicles with less than 660 CCs must pay this tax. For details, contact the Tax System Division of Suita City Hall.

[Consumption tax]

A tax of 8% or 10% is paid on top of the price of an item or a service.

Tax certificates issued at the city hall

The certificate of taxable income for prefectural or municipal taxes or the payment certificate for prefectural or municipal taxes may be required when you renew the status of residence or rent/purchase a home.

[Certificate of taxable income for prefectural and municipal taxes]

- This certificate is equivalent to the tax certificate and the tax exemption certificate.
- It tells "the incomes during the previous year" and "the tax amount".
- Those who did not declare for the previous year incomes are not eligible to receive this certificate. For details, contact the Tax System Division of Suita City Hall.

[Payment certificate for municipal taxes]

- This certificate proves that "the person paid the municipal taxes".
- There are tax payment certificates for the municipal/prefectural taxes, property tax, corporate inhabitant tax, etc.
- These are issued only for those the municipal taxes are imposed on. For details, contact the Tax System Division of Suita City Hall.

[Certificates for other municipal taxes]

The certificates for fixed assets (ex. land or houses) are issued for those who own land or houses in Suita City.

Pregnancy and Childbirth

When you become pregnant

[Delivery support system] Providing a subsidy for childbirth

In case the parents do not have enough money to give a birth due to their financial problems, Suita City will provide a subsidy for them.

(Eligible people)

- · Residents in Suita City
- *There are some cases that the parents are ineligible for this system, so be sure to consult with the Child-rearing Support Division of Suita City Hall by the time of delivery.

When you find out about your pregnancy

- ①Submit the pregnancy notification (the form to notify your pregnancy) to the Maternal and Child Health Division of Suita City Hall or that in Minamisenri Branch Office.
- ②Receive a Maternal and Child Health Handbook (Boshi kenko techo). The English, Chinese, Thai, Vietnamese, Portuguese and Korean versions are also available.
- ③Receive a "Separate Volume of Maternal and Child Health Handbook" as well.
- *Maternal and Child Health Handbook
- Bring your Maternal and Child Health Handbook when you go to the hospital.
- The handbook tells important things to raise your baby.
- Record how your baby is growing and what kind of diseases they got.
- Record the types of vaccination (shots to prevent diseases) your baby got.
- **Separate Volume of Maternal and Child Health Handbook
- If you bring this with Maternal and Child Health Handbook, you can get some supports on the prenatal checkups (14 times).

Maternity Mark

Your baby's growth and your safety should be assured especially at the beginning of pregnancy.

Please put this mark (ex. on your bag) when you ride on a train or a bus, then other people can notice that you are pregnant.

Prenatal checkup

- You can check your condition and how your baby is growing inside your body.
- You can receive tickets for the prenatal checkup with your Maternal and Child Health Handbook. Bring them to designated hospitals (partner medical institutions).
- In case the payment for the checkup exceeds the amount written on the tickets, you will need to pay for the excess.

Prenatal dental checkup

• You can receive a dental checkup for your teeth and gum, cleaning of the tooth surface, toothbrushing instruction, etc. once for free during pregnancy. Make a telephone reservation of a partner dental clinic before visiting.

Counseling service for prospective mothers

• If you are worried about delivery and child-raising, you can consult with midwives or public health nurses. You can ask for advice on the phone as well.

Prenatal classes (for expectant mothers and fathers)

- Preliminary application is required.
- · New parents can learn important things about pregnancy, childbirth, and child-raising.
- There is also a class where you can experience holding a baby, changing a diaper, etc. using baby dolls.

Newborn hearing screening (checking the baby's hearing ability)

• It is said that 1 or 2 out of every 1,000 babies have an inborn hearing impairment. During hospitalization, you can take a screening shown below at the hospital where you gave a birth.

Automated ABR screening (5,000 yen) or OAE screening (1,500 yen)

※In case the payment for the screening exceeds the certain amount, you will need to pay for the excess.
※There are some hospitals that do not carry out the screening. Be sure to inquire with the hospital where you are planning to give a birth beforehand.

Counseling service for mothers in the postnatal period

• If you are worried about child-raising, you can consult with midwives or public health nurses. You can ask for advice on the phone as well.

Home consultations for newborns, infants and mothers

- Public health nurses and midwives are available for home visits for consultations on breastfeeding and other matters relating to childrearing, as well as hearing any worries about the health condition of the parents.
- Applicants need to mail the postcard (birth notification form) attached to the Separate Volume of Mother and Child Health Handbook. Application by telephone or on the official website of Suita City is also available.

Postnatal checkup

• This is carried out in 2 weeks and 1 month after the delivery to check the mother's physical and mental health. You do not need to pay up to 5,000 yen per checkup.

Postnatal dental checkup

- New mothers tend to be too busy taking care of their babies, so they do not pay enough attention to their teeth and gums, which may cause cavities. It is said that if mothers have cavities, the risk of their children developing cavities as well increases.
- Mothers can undergo a free dental health checkup within 1 year after giving a birth (by the day before their children's first birthday). Be sure to make a telephone reservation of a partner dental clinic before visiting.

General health check for infants

- This is conducted at the designated hospitals (partner medical institutions).
- Your baby can have this checkup once at no cost within the first year of birth.
- Be sure to make a reservation, and then go to a partner medical institution with the medical card attached to your Separate Volume of Maternal and Child Health Handbook.

Health check for infants

- Your baby undergoes the checkup ①-⑤ listed below to measure their size and weight, and to see if they have any disease.
- The Maternal and Child Health Division of Suita City Hall will send a medical card to the address of those who are eligible for the checkup.
 - ①Health check for four-month-old infants Late infancy health check (from nine-month to one-year-old infants)
 - ②Health check for one-and-a-half-year-old infants
 - 3 Dental health check for two-and-a-half-year-old children
 - 4) Health check for three-year-old children
 - (5) Molar teeth health check for six-year-old children

Postnatal care/support services

- In case you are sick or worried about child-raising while there are not enough supporters around you, do not hesitate to ask for help. We will introduce medical institutions, etc.
- This is available within 2 months after the childbirth. You cannot use it if the mother or the baby needs to be hospitalized. In case you gave birth to twins or a low birth weight infant, the available period may be extended.
- The mother and the baby can receive consultation about rest and child-raising at hospitals. You can choose from a day trip or a stay.
- Fees are required.

Postnatal housework support

- In case you are sick or worried about child-raising while you cannot rely on your family, you can receive supports on house cleaning, cooking, etc.
- This is available within 6 months after the childbirth.
- · Fees are required.

Support for families with multiple birth

- If you have twins, triplets, or more who are younger than 1 year old, you can receive supports on house cleaning, washing, child-raising, etc. You cannot use this service if you need to be hospitalized.
- Fees are required.

Relaxing room for pregnant women and new mothers

- Pregnant women and new mothers (within two months of giving birth) can spend relaxing time with their babies and talk to each other freely.
- They can learn about child-raising and consult with midwives and public health nurses.



- To prevent infectious diseases, the babies' siblings and people in bad condition are not accepted.
- Pregnant women are recommended to join after 20 weeks of pregnancy (after the first trimester).

Vaccinations (shots to prevent babies from diseases)

- Prevaccination screening questionnaire

A Child Rearing

Allowances and subsidies

[Child Allowance] An allowance provided by Suita City to child-raising families

(Eligible people)

• Families that have children of junior high school or under (by March 31 after turning 15 years old) are eligible. Submit the form to the Child-rearing Support Division of Suita City Hall.

(The amount of allowance)

- 0 under 3 years old: 15,000 yen / month for each child
- 3 12 years old (until graduating elementary school): 10,000 yen / month for each child
- If the family has more than 3 children who are younger than 18 years old, 15,000 year / month is provided from the third child.
- 12 15 years old (until graduating junior high school): 10,000 yen / month for each child

Households whose income (ex. salary) is judged to be enough to raise children will receive 5,000 ven / month for each child.



[Child Support Allowance] An allowance to raise children

Those who are raising children younger than 18 years old alone due to divorce, etc. or those who are raising children with disabilities younger than 20 years old are eligible to receive this allowance. Submit the form to the Child-rearing Support Division of Suita City Hall.

[The amount of allowance per month]

- ①one child: 10,180 43,160 yen
- ②two children: 5,100 10,910 yen in addition to ①
- (3) three children or more: 3,060 6,110 yen in addition to (1) and (2)



- The amount is decided based on the previous year's income (ex. salary).
- In case the income (ex. salary) exceeds the amount decided under the system, this allowance is unavailable.

[Medical subsidy for single-parent families] A subsidy for illnesses or injuries For those who are raising children younger than 18 years old alone and their children are suffering from illnesses or injuries, Suita City pays part of the medical expenses.

- Apply to the Child-rearing Support Division of Suita City.
- The "Medical care certificate for single-parent family" will be sent to your address.
- In case the income (ex. salary) exceeds the amount decided under the system, this allowance is unavailable.

Child-rearing support

[Child-rearing workshop] A workshop where parents and children play together and make friends

This is held twice (in spring and fall) at kindergartens in Suita City.

It is announced in "City Guide Suita (Shiho Suita)" as well.

[Carefree Childcare Plaza (Nobi-nobi Kosodate Plaza)] A facility to learn about child-rearing

Parents can get information about child-rearing through learning and interacting with other parents. There are various contents suited for the children's age, such as parent-child lessons, gatherings, lectures to learn about child-rearing, etc.

[Suita Family Support Center] Mutual support for child-rearing

This is a group where residents of Suita City help each other. They introduce people who can take care of your children. Fees are required.

[Childcare classes for non stay-at-home guardians] A place where children can play and study

In case the schoolchildren's family members are away from their home after school, they can play and do their homework safely in their elementary school. The usage fee is required.

(Eligible children)

- · Monday Friday and the 4th Saturday of the month
- From the end of the final class to 5 p.m.
- Extended care is available: from the end of the final class to 6:30 p.m.
- The 4th Saturday: from 8:30 a.m. to 5 p.m.

(During summer/winter/spring vacations)

- From 8:30 a.m. to 5 p.m.
- Extended care is available: from 8:30 a.m. to 6:30 p.m.

(Usage fee)

- 4,000 yen per month
- Payment is required for everything else (ex. snacks).
- Extended care requires extra 1,500 yen.

Nursery schools and kindergartens

(Schools that educate and take care of children younger than school age)

Children younger than 6 years old (before entering elementary school) are eligible.

There are 3 types of schools, "nursery schools", "kindergartens", and "certified centers for early childhood education and care".

[Nursery schools] There are municipal and private schools.

- In case the parents cannot take care of their children due to their job or sickness, the schools will take on their care.
- There are some nursery schools that can take care of the children for a short time ("temporary childcare") for the parents who cannot do that due to sickness or a busy schedule.

(How to apply)

- Whether it is municipal or private, apply to the Nursery Schools and Kindergartens Office of Suita City Hall.
- If you attempt to use a nursery school from next April, you should apply in the fall of the previous year.
- If you do not care about the entrance month, you can apply anytime.

[Kindergartens and certified centers for early childhood education and care] There are municipal and private schools.

The period of entrance is April of every year. If you attempt to start school in another month, inquire with your preferred school.

- Public kindergartens and certified centers for early childhood education and care
 - Public kindergartens offer two-year care service for children aged 4 and 5.
 - Certified centers for early childhood education and care offer three-year care service for children aged 3 5.
 - The parents must pick up their children by themselves.

(How to apply)

- If you attempt to use a school from next April, receive the documents (application forms) from public kindergartens, certified centers for early childhood education and care, or the Nursery Schools and Kindergartens Office of Suita City Hall from September of the previous year.
- Submit the application form to your preferred school during the designated period in October of the previous year.
- In case of a large number of applicants, places will be decided by lottery.

■ Private kindergartens

There are 16 private kindergartens in Suita City, which offer 3-year childcare service for children aged 3 - 5. Some of them provide a pick-up bus service.

(How to apply)

If you attempt to enter a school from next April, apply to your preferred school in October of the previous year.

Tuition for nursery schools and kindergartens became free.

- If your children are 3 5 years old, you do not need to pay the tuition for nursery schools and kindergartens.
- The tuition is not required for 0 2 years old children in the households that municipal taxes are not imposed on.
- Payment is required for snacks, clothes, etc.

(Nursery schools and kindergartens that are free of the tuition)

- Inquire with your children's nursery school or kindergarten to know whether you are eligible for free-tuition service.

Schools and Education

Support for non-Japanese residents [Sakura Hiroba] A class to learn Japanese

This is held for children who need support to live and study in Japan and wish to know about the culture and language in their home countries.

(Eligible children)

School system in Japan (From elementary school to university)

All children must go to elementary schools and junior high schools. This is called "compulsory education".

[Elementary and junior high school (compulsory education)]

All children go to elementary schools from 6 years old and junior high schools from 12 years old. Non-Japanese children can go to Japanese elementary schools and junior high schools as well.

[When non-Japanese children wish to go to Suita Municipal elementary schools and junior high schools]

- Apply to the Educational Affairs Division of Suita City Board of Education.
- The division will send you the document (admission notice) in which your child's name, birthday, the school to go, etc. are written.

[When transferring from an elementary school or junior high school in another city to a municipal one in Suita City]

- Please submit the moving-in notification to the Municipal Division of Suita City Hall and receive the "Notification of Transfer".
- Please submit the "transfer notification" and the "documents required for transfer" given by the previous school to the new school.

[When transferring from a Suita municipal elementary school or junior high school to one in another city]

- Please submit the moving-out notification to Municipal Division of Suita City Hall and receive the "notification of leaving school".
- Please submit the "notification of leaving school" to the current school.
- Receive the "documents required for transfer" from the school and submit them to the new city hall and school.

[When moving within Suita City and the school area changes]

(School area)

Which elementary school or junior high school to go is decided based on where the resident lives.

- Please submit the notification of change of address to the Municipal Division of Suita City Hall and receive the "notification of leaving school" and the "notification of transfer".
- Please submit the "notification of leaving school" to the current school.
- Receive the "documents required for transfer" from the school, and submit them with the "notification of transfer" to the new school.
- In some cases, the school does not change even if the resident changes their address.

[Subsidy for education]

School financial aid

- Elementary school and junior high school students whose family is in financial difficulty can receive aid to pay for school lunch (only for elementary school students) and school supplies (ex. stationery).

Welfare and Nursing Care Services

Nursing Care Insurance

Those who are covered by a nursing insurance can receive nursing care services when they grow older, become seriously sick, or need nursing care (ex. support for eating and bathing).

(Eligible people)

- Those who live in Japan longer than 3 months and have a medical insurance (Health Insurance, National Health Insurance or Medical Insurance for Older Senior Citizens) can join a nursing insurance when they turn 40 or older. The procedure is supposed to be completed by the companies they belong to.
- All people who live in Japan longer than 3 months join a nursing insurance when they turn 65 or older. No procedure is required.

(People eligible for nursing-care services)

- ■Elderly people aged 65 and over
- When they are recognized as those who need nursing care by Suita City.
- When they are recognized as those who need support to live by Suita City.
- Medical insurance subscribers aged 40-64
- When they are recognized as those who need nursing care by Suita City.
- When they are recognized as those who need support to live by Suita City.

(Nursing-care services offered)

The services vary depending on the users.

(Payment of premiums for nursing insurance)

- Elderly people aged 65 and over
- People who annually receive pension of 180,000 yen or more:
 - • The premiums are deducted from the pension.
- Those whose pension is less than 180,000 yen / year:
 - • Payment should be made by themselves with using the statement of payment. It is payable at banks, post offices, convenience stores, or on smartphones (LINE Pay or PayPay).
- Medical insurance subscribers aged 40-64
- The premiums are paid on top of their medical insurance premiums.

(Amount to be paid for services)

- You are required to pay 10% of the original fee when you receive the services.
- Those who have a high income are required to pay 20% or 30%.
- If you are hospitalized, part of the medical care fees are covered, which means you are required to pay the charges for food and your stay by yourself.

*Required fees are fixed not to be too expensive.

People with disabilities

[Services for adults and children with disabilities] Support to enable people with disabilities to live and join the society in their area

(Issuance of a disability passbook to receive the services)

Receive a disability passbook at the Disability Welfare Office. It is necessary to use welfare services. It usually takes 1 - 3 months from application until receiving it.

(Types of passbooks)

- ①Physical Disabilities Passbook (Shintai Shogaisha Techo) People with disabilities caused by illnesses or injuries
- ②Rehabilitation Passbook (Ryoiku Techo) People with intellectual disabilities
- ③Health Care and Welfare Handbook for People with Mental Disabilities People who have difficulty to live because of mental disabilities

(Services offered)

- · Lower taxes
- · Discount on taxi fares

Medical insurances

Insurances to prepare for illnesses and injuries.

Those who are covered by medical insurance will be required to pay part of fees when they receive a medical examination at the hospital. The rest is paid by the national government and the city hall. There are three types of medical insurances. All people are required to join one of them under the Japanese law.

- ①National Health Insurance ②Social Insurance (health insurance of the workplace)
- 3 Medical Insurance for Older Senior Citizens (only for people aged 75 or more)

1) National Health Insurance

When you enroll in/withdraw from the National Health Insurance or change your address, submit the form to the National Health Insurance Division of Suita City Hall.

(Eligible people)

- Non-Japanese people who (are going to) live in Suita City longer than 3 months
- Those who are not covered by the health insurance of their workplace
- Those who are younger than 75 years old
- Those who are not receiving any social security benefits

(Enrollment must be done within 14 days after the following events)

- Withdrawal from the health insurance of the workplace
- Moving
- · Birth of a child

(Insurance premiums: Fees for insurances)

- Premiums should be paid every month.
- The amount is decided based on the family size and the income of the previous year.
- If you want to lower the premiums because of disasters (ex. earthquakes) or sudden decrease of income, consult with the National Health Insurance Division of Suita City Hall.

(Payment of premiums)

 After the enrollment in the National Health Insurance, the statement of payment will be sent from the National Health Insurance Division of Suita City Hall. Make a payment at banks, post offices, or convenience stores by the due date.

(Withdrawal must be done within 14 days after the following events)

- Enrollment in the health insurance of the workplace
- Moving from Suita City to another city, town or village
- Death of the person insured by the National Health Insurance



Those who have special certificates (ex. the status of residence for medical-stay of "Designated Activities") cannot join National Health Insurance.

2 Social Insurance

• Those who are working at a company and meet certain conditions (ex. the amount of monthly salary) usually join the health insurance of the company. Inquire with your company whether you can join the health insurance.

Suita City Hall is not in charge of the procedure.

• Your family members who live in Japan can join the health insurance as well. Inquire with your company whether your family members are eligible.

3 Medical Insurance for Older Senior Citizens

(Eligible people)

- People at the age of 75 or older
- Non-Japanese people who (are going to) live in Japan longer than 3 months. Those who have any special status of residence cannot join.

(Enrollment)

- An health insurance card will be sent to your house in the previous month of your 75th birthday.
- If people aged between 65 and 74 are recognized as those with disabilities by the city hall, they are eligible to join this insurance as well.

Various health checkups (medical examinations)

If you become sick or injured

In case of illnesses or injuries, do not hesitate to go to the hospital. Make sure that you bring your health insurance card with you when you visit the hospital for a consultation.

XIn case you undergo a medical examination without your health insurance card · · · • • Make a full payment for the consultation and so on.

The methods to receive a refund of overpayment are shown below: [People enrolled in National Health Insurance]

Bring the receipt (the amount of payment is required) and your National Health Insurance card to the medical institution where you received the consultation. If the procedure is completed by the end of the month of the consultation, you may receive a refund from the institution.

If you want to receive a refund after the month of the consultation, go through the procedure at the National Health Insurance Division of Suita City Hall.

Medical subsidy

[Medical subsidy for children] A subsidy for illnesses or injuries of children When your child gets sick or injured, or is hospitalized, the city hall will share the cost. If you apply to the Child-rearing Benefit Division of Suita City Hall, a "medical certificate for children" will be sent by mail. Bring the "health insurance card" and "medical certificate for children" when you take your child to a hospital in Osaka Prefecture.

(Eligible children)

- · Residents in Suita City
- Insured people of a health insurance
- Those who are younger than 18 years old or until March 31st after their 18th birthday
- Those who are not receiving any public assistance

(Putting out the garbage)

- Take out the designated types of garbage by 8 a.m. of the designated collection day.
- Separate the garbage into their different types and put them out at the designated garbage collection place.

Breaking the rules will cause trouble to your neighbors.

- Do not put the garbage out on days other than the decided ones.
- Do not put the different type of garbage out on days when another type is designated.
- Do not put the garbage out in places other than the decided one.
- Do not put the garbage out without sorting it.
- Do not take others' garbage home.
- Those who bring back other's garbage may have to pay a fine.

[Garbage collection related to moving out]

- Call the Operations Division of Suita City Hall between a month and 14 days before moving.
- Sort out the garbage in accordance with the sorting rule of Suita City.
- ・Put it out with the label that shows your name and " 引っ越しごみ " (moving-out garbage)" on the moving day.
- Waste disposal fee is required.

[Garbage not collected by Suita City]

- (1) Air conditioners, Televisions, Refrigerators, Freezers, Washing Machines, and Dryers Take them out to the shop where you bought them. Fees are required.
- (2) PCs

Inquire with the PC manufacturer or use the pickup service of ReNet Japan Group, inc.

- (3) Button batteries, nickel-cadmium batteries, nickel-metal hydride batteries, and portable chargers Take them to electronics stores, etc.
- (4) Others

Items specified as "non-collectible items" by the city

[Recyclable items collected at designated places]

(1) Plastic Bottles

Put them into the collection box at partner supermarkets and Suita City Hall.

**Remove caps and labels, and wash bottles before putting them into the collection box.

(2) Used edible oil (Oil used for cooking or one that became unusable)

Put it into the collection box at Suita City Hall, etc.

*Be sure to put it into airtight containers.

(3) Empty contact lens cases

Environmental Beautification

[No smoking while walking. No cigarette littering.]
Smoking while walking and littering are not allowed throughout Suita City (except for private land) to keep the city clean. When you smoke, make sure to stop walking as not to block the way, keep the rules and mind your manners.

In case littering or smoking are found around the stations below other than in the smoking area designated by the city (except for private land), a fine may be imposed.

Daily Living

Housing

[Municipal housing (rented by Suita City) and prefectural housing (rented by Osaka Prefecture)] (Non-Japanese people who are eligible to rent municipal housing)

Those who fulfill all the requirements ①-③ below:

- (1) The one lives and/or works in Suita City.
- ②The person has difficulty in their current housing situation.
- ③The person's income (ex. salary) is lower than the income standards decided by Suita City (the amount depends on the family size).

Applicants will be informed in "City Guide Suita (Shiho Suita)".

The required document (application form) is available at Suita City Hall, the branch offices (in Senri, Yamada and Senrioka), and Public Service Corner (in Suita Thanks Bld. Esaka, Kishibe, Hara or Kitasenri). The tenants are decided by lottery.

(Non-Japanese people who are eligible to rent prefectural housing)

- ①The person lives and/or works in a city/town/village in Osaka Prefecture.

- ③The person's income (ex. salary) is lower than the income standards decided by Osaka Prefecture (the amount depends on the family size).

[Companies that introduce places to live in (real estate companies)]

- Decide the conditions to live in, such as the rent, security deposit, area, size of the place, etc.
- When you decide where to live, pay a commission to the real estate company that introduced the place.
- Sometimes a security deposit and key money are required in addition to a commission.

Housing-related vocabulary

| Rent: yachin | The payment to rent a house/apartment. |
|--------------------------------|--|
| Commission: reikin | This is a mandatory payment to the landlord (the person who rents the place). |
| Agent's commission: chukai-ryo | This is a commission paid to the real estate company that introduced you the place. |
| (Joint) guarantor: hoshonin | This is a person who assumes rent payment in case the tenant is not able to pay it. In principle, a guarantor is required to rent a house/apartment. |

Water

[Procedure to receive water service]

- An application form for water usage will be posted on the front door (or somewhere around) of the house/apartment where you are going to live.
- Write your name, the starting date of use, etc. on the form and send the attached postcard to the Waterworks Department of Suita City Hall. No stamps are required. You can also apply on the phone.
- If you live in an apartment, you may need to go through a procedure that enables the management association of the apartment or the landlord to use water.

[Water is ready to use when moving-in.]

(In case water does not come out)

- Call the Waterworks Department of Suita City Hall.
- The staff of the department will visit your house to switch on the water.

[Payment for water charge (the money paid for water usage)]

(Water charge)

- This is divided into two types: the charge imposed even if water is not used (basic charge) and the charge imposed depending on the amount of water usage (usage charge).
- If the resident uses the sewage (dirty water which comes out from toilets and baths) service, they must pay the sewage service charge as well.
- · Water charge is paid once every two months.

(How to pay water charge)

- Make a payment at banks or convenience stores.
- · Direct debit is also available.
- If you live in an apartment, the management association of the apartment or the landlord may request the payment after checking the total water usage amount of all tenants.

Bicycle parking

[Bicycle parking lots] Parking areas for bicycles and motorcycles

- Leaving bicycles or motorcycles on the road disturbs others.
- They should be parked at the parking lots near the stations.

[No parking zone for bicycles and motorcycles] Areas where bicycles and motorcycles parking is prohibited

The zones have been set up to eliminate abandoned bicycles and motorcycles around the stations. If they are left in the zones for a long time, the staff of Suita City Hall will remove them and take them to the storage centers.

(Fees required)

In case the bicycle or motorcycle is removed to the storage center and the owner attempts to get it back, they must pay a fee for removal and storage.

· Bicycles: 3,000 yen

· Motorcycles: 4,500 yen

"Suita City Public Transportation Map", which provides information about trains and buses running in Suita City, is available (Japanese version only).

Dogs or cats breeding

- If you have any pet, be careful not to cause trouble to others.
- In case you (are planning to) live in a rental house or an apartment, make sure to check whether pets are allowed in advance.
- Do not let your dog run freely. Keep your cat inside.

Rules for dog breeding

(Procedure)

- · Register your dog at Suita Health Center.
- Receive a dog license that allows you to have a dog. Fees are required.

(Necessary care)

- Receive a vaccination for rabies prevention every year.
- Bring the certificate of vaccination given by the animal hospital to Suita Health Center.
- Receive the certificate of rabies vaccination (vaccination slip). Fees are required.
- Put the dog license and the vaccination slip on your dog's collar, etc.
- Put stickers (ex. "DOG AT HOME") on the entrance door or somewhere easy to find to notify others that you have a dog.

Death of your pets (dogs/cats)

- Call the Operations Division of Suita City Hall, which will take care of them. Fees are required.
- If your dog dies, call the Public Health Management Division of Suita Health Center.
